In terms of the Financial Services and Markets Act 2000 ("FSMA") and the Financial Services and Markets Act 2000 (Financial Promotion) Order 2005 (as amended) ("FSMAO"), our lawyers, MBM Commercial LLP ("MBM") can only complete "Archangel" investments on your behalf if they have evidence that you are either a "**certified high net worth individual**", "**self-certified sophisticated investor**" or a "**certified sophisticated investor**". If you are in either of these categories then you are exempt from the provisions of the FSMA. It is a legal requirement that you can exhibit suitable documents to this effect prior to completion of any investments as a member of Archangels.

To satisfy the requirements of the FSMA you must do one of three things:

1. Sign a Declaration that you are a "Certified High Net Worth Individual":

The prescribed form of wording is shown on page 2 overleaf. Please note that a Statement to this effect must be signed on an annual basis.

We anticipate that anyone wishing to join "Archangels" as a new member or renewing their membership after a period of non-membership of 6 months or more will want to make use of this option.

2. Sign a Declaration that you are a "Self-Certified Sophisticated Investor":

The prescribed form of wording is shown on page 3 overleaf. Please note that a Statement to this effect must be signed on an annual basis.

We anticipate that anyone who is a current member of "Archangels" (and has been for at least 6 months on a continuous basis) will want to make use of this option.

3. Sign a Declaration that you are a "Certified Sophisticated Investor" and also obtain a Certificate from an Authorised Person confirming that this is the case:

The prescribed form of wording is shown on page 4 overleaf. Please note that a Declaration to this effect must be signed by you on an annual basis, although an authorised person need only sign the Certificate (comprising part 2 of the Statement) once every three years.

We anticipate that this option will only be used by new members of "Archangels" who do not meet the net asset or annual income test referred to the Certified High Net Worth Individual Declaration (per option 1 above).
